Committee Spotlight - Olivier Picard

In each edition of the newsletter, we feature a member of the committee. This month we are pleased to introduce Olivier Picard. Olivier has been a community pharmacist for over 20 years. Olivier was one of the first pharmacists to become a non-medical independent prescriber in 2007, a post graduate certificate obtained with the University of Reading. Services Update



Discharge Medicines Service (DMS)

We are working hard to increase DMS referrals into every pharmacy. We have four Trusts in our area: Royal Berkshire Foundation Trust and Buckinghamshire Healthcare Trust, both of which use PharmOutcomes for referrals; and Oxfordshire University Hospitals Trust and Frimley Health Foundation Trust, who both currently use NHS mail. Pharmacies should be checking for referrals at regular intervals throughout the day and ensure they start the DMS process within 48 hours of receipt. Click here



GP CPCS

There is a strong commitment by both Frimley and BOB ICS to ensure that referrals from GPs to pharmacies continue to increase. Our Contractor Support Officer, Kevin Barnes, is working with PCN Clinical Directors and Practice Managers to ensure the successful roll-out of GP CPCS across the region, including the training of Practice Staff across BOB. Early Hormonal Contraception (EHC)

Oxfordshire – A reminder to all Oxfordshire EHC providers that the Ulipristal PGD has been added to the Oxfordshire EHC service and, if you have not already done so, you need to re-enrol for both Ulipristal and Levonelle on PharmOutcomes right away. Please also ensure that your DBS certificate is up to date. The Oxfordshire Public Health team are currently running a campaign to raise awareness of the service and you will be sent a poster which you are asked to please display in a prominent position. Buckinghamshire – we are working with the Buckinghamshire Local Authority team who will be adding Ulipristal (EllaOne) to the current EHC specification shortly. Please look out for an update in the very near future.

We will share the flu specification as soon as it is available but, in the meantime, you may wish to consider pre-booking appointments for patients, both private and NHS. Virtual Outcomes Online Pharmacy Training

All CPTV pharmacies now have access to Virtual Outcomes. This is a suite of short (approx. 15 minute) online training courses and podcasts on a variety of subjects including IBD, Adrenaline Auto Injectors, Menopause and Atrial Fibrillation. The topics support both national and local public health campaigns. Team members have an opportunity to gain a certificate which can be used as evidence of training for the GPhC and/or Healthy Living Pharmacy file. This Anticoagulation & Thrombosis teaching session for community pharmacists, pre-regs and technicians will be run by Victoria McDonnell, Lead Anticoagulation and Thrombosis Pharmacist at OUH. The session will cover both DOACs and warfarin, exploring indications, doses, interactions and duration of therapy. It will also include a review of counselling points and signposting to other sources of information for both healthcare professionals and patients to assist with the DMS and NMS reviews.
