Pharmacy owners should note that de-registering from the service after 31st August 2025 will make them unable to fulfil the gateway criteria for PQS 2025/26, and consequently any Aspiration payments they have already received will be reclaimed from them at a future date.  In addition, to receive the Pharmacy First Clinical Pathways monthly payment from June 2025, pharmacies need to be signed up to provide both the Hypertension Case-Finding Service (except Distance Selling Pharmacies (DSPs)) and PCS.
